# **Ventura Social Services Task Force**

#### Minutes of Meeting January 6, 2010

Meeting called to order by chair John Jones at 3:04 Self-introductions performed.

- I. Steering Committee elections
  - A. The following was proposed for adoption:

Responsibilities and Expectations for VSSTF Steering Committee (SC) Members

- Attendance (present and on time)
   If a SC Member is absent from any 3 out of 5 consecutive SC meetings, they
  may be replaced upon recommendation of the SC Members and vote of the
  full VSSTF.
- Support of positions, policies, and programs of VSSTF SC Members are expected to actively support the mission of the VSSTF and should not publicly express a position against policies which have been voted on or clearly embraced by the VSSTF.
- Active member of 1-2 subcommittees
- On direction of VSSTF or SC, attend meetings or events, represent VSSTF, and perform assignments. SC Members can be asked at any time to prepare a report on their activities. It is expected that SC Members will actively pursue activities which support the mission of the VSSTF.

Moved by Bill Finley and seconded by Debora Schreiber. **Adopted.** Voting no: Ken Finning, Sherry Cash, Daniel Zapata.

- B. The steering committee recommends going back to a **3 member** committee. It is difficult to coordinate time to meet for 4 people, an odd number is preferable in case of tie vote, and 3 is the number set out in the Membership Policy, adding a member was done as a trial for 2 years.

  Motion made by Mike Merrewether seconded by Neal Andrews, passed.

  Abstain, Daniel Zapata. A suggestion was made that the steering committee schedule one firm meeting a month and publicize the time and place on the web page. Suggestion accepted.
- C. Chair of the meeting was handed to Neal to conduct the elections. Nomination was made by Peter Brown, to elect **John Jones chair**: Jan Christian nominated **Bill Finley as vice chair**. Both were elected by acclamation, with Danny Zapata abstaining. Mike Merrewether nominated **Debora Schreiber for secretary**. elected by acclamation, Sherry Cash and Danny abstaining.

#### II. Report on City Activity by Peter Brown

- B. City Council Homeless Committee not yet appointed (update: Mayor Fulton is recommending Neal Andrews, Christy Weir, and Mike Tracy). The appointments will be made at Council meeting on 1/11. A meeting will take place of this committee in January. The agenda will include a) Safe Sleep b) request by VSSTF to allow city money given to VSSTF to go to help individuals with basic needs(currently not allowed) c) River Haven update and d) Neal agreed to place on the agenda the VSSTF request regarding moving forward with plans for a permanent shelter.
- C. Winter Warming at Armory running slightly below previous years, probably due to lack of designated transportation. Karol Schulkin notes that the clients seem to be more vulnerable physically than in previous years. No problems have been reported to police nor complaints from the Mall or elsewhere.
- D. Kingdom Center was approved and persons will move in very soon. Operation Embrace, the Day Program, must go back to Planning and Council for CUP. They are not planning to open for several months.
- E. The mini-park behind the Farmer's Market lot is privately owned and plans are underway to gate it off for catering party events. This will be before DRC on 1/13.
- F. Issue brought up about the resolution which VSSTF brought to Council last fall regarding Permanent Shelter and Housing Element. Site location and funding part did go forward to Economic Development. Neal will bring issue forward at January Council Homeless Committee meeting. Gateway Committee has done some work on site search.

# III. El Patio report Jill Martinez

Peoples' Self Help Housing now owns El Patio. There are 20 vacancies. The on site manager is Michel. They are cleaning up illegal activities and moving forward. Renovations taking place.

# A. Faith Communities by Bill Finley

Long discussion at meeting about accountability and moving the process forward ...who is leading the process? Need increased clarification of the role of the Task Force and increased leadership to make projects move.

## **B.** Homeless Prevention by Cindy Cantle

1. No meeting was held in Dec. In Nov., Catholic Charities assisted 2 households, in Dec. 3 households. They will have the fund in Jan. In Feb, Project will. In March, Salvation Army. In December, \$5262 was received. Fund stands at around \$7000. EFSP funds applied for. Hope that VHPF money can help to fill in gaps for Federal Funds (HPRP) which exclude some people. Estimated roughly that 2/3 of HPRP money will go for eviction prevention and 1/3 to put people in housing.

## C. Housing Options by Loretta McCarty

- Home Share Program up and running 477-7324 or <u>homeshare@gmail.com</u>. Several presentations have been made to spread the word and flyers are available. Muriel is working as a volunteer and Ken Finning is coming to One Stop to help get people into Home Share.
- Housing Authority is moving forward with 2 housing projects.
   One on Oak and Thompson next to Salvation Army. The lot is
   fully entitled. It will have 37 units for very low income. The
   second site is the old Bandar site on Main which will be special
   needs population using HUD 811funds which includes case
   management.

## D. Gateway Report by Clyde Reynolds

There was no Dec. committee meeting. Service Providers met to discuss ways to co-locate services. Further discussions will be held and outreach to the private sector will be made.

# F. Steering Committee by John Jones

- 1. Beginning to make plans for a 3 hour retreat with facilitator to hash out direction and accountability within Task Force
- 2. The committee to evaluate funding proposals to the City will meet soon.
- 3. Several people going to NAEH in LA: John, Debora, Sherry, Bill, Danny, Cathy, so far. Bill can drive a van to commute.

- 4. Possibility of turning public testimony supporting Kingdom Center into a brief 10 minute video. Anyone interested and have ability to work with CAPS on it?
- 5. In April there is a Housing Conference in Sacramento. Cathy suggests presenting the VHPF and maybe HomeShare. The presenter can attend free of charge.

#### V. Old Business

- 1. Report on One Stop by Kate Mills. By end of the calendar year 2009, more than 3000 persons and 1200 unduplicated persons served. Over 490 are younger than 35. 5300 lunches have been distributed, 1500 persons (half) seen in clinic. Attempting to connect HomeShare with General Relief (GR) allocation to help people get housing and money in a package.
- 2. Homeless Count on Jan 26. Not required at this time but garners the county increased points with HUD for funding. Please sign up to help.

#### VI. Announcements

- 1. Cathy says CSUCI students are doing data search for information. What info might be useful? Bill suggest finding out how many people are sleeping in their cars. Also possibly of value, number of ER visits by homeless persons.
