I. Introductions and Announcements

II. Subcommittee and Other Reports

A. Peter Brown – Updates

- 1) Over the past 3-4 months there has been an ongoing discussion regarding illegal camping in the Ventura River bottom. There are 10-12 permanent camps and the residents of those camps have been notified that they can't stay in those camps any longer.
- 2) The Safe & Clean program is continuing.
- 3) In September the CLU cleanup will take place. The students may be involved in removing homeless camps from the river bottom.
- 4) Rick Cole The river bottom has been a homeless "solution" for some people. Moving them out creates possible new alternatives for persons who have lived in the river bottom.
- 5) There are 4 subcommittees that have been formed to try to find effective ways to deal with the issue of moving people out of the river bottom. The subcommittees and their chairs are as follows: "Humane Enforcement" Mark Stadler, "Broadened Partnerships" Josh Addison, "Logistics" Carrie Glen, "Reasonable Alternatives" Rob Orth. There have been two large group meetings so far and there will be ongoing subcommittee meetings. The main issues of concern are: 1) How to get the word out to "clients" who will be displaced; 2) Possible consequences of this "move out"; and 3) Who expects what to happen?
- 6) The 100,000 Homes program is still trying to move forward and the City of Ventura will have a role in this process through partnerships with private business.
 - B. Faith Community Subcommittee Debora Schreiber (for Sue Brinkmeyer)
 - 1) There is a need for a co-chair for the subcommittee.
 - 2) The subcommittee will be doing outreach to faith based organizations to see who they help (i.e., their own members, other people in their neighborhoods, who else?).

- 3) The subcommittee is looking to find what food pantries are available for people. They are also looking to get contact information for people.

C. Homeless Prevention Subcommittee – Cindy Cantle

- 1) The fund was with Salvation Army for June but they were able to use Rotary funds for assistance.
- 2) The fund will be with Catholic Charities for July. A family of 5 (2 adults, 3 children) received assistance so far.
- 3) The current balance in the account is \$4,000.
- 4) John Jones, Jill Forman, Debora Schreiber, Harold Cartlidge, and Dorothy Fast Horse manned the VSSTF booth for the July 4th street fair. They collected \$140.

E. Gateway Group Subcommittee – Clyde Reynolds

- 1) The meetings have focused on putting together a system for the "Virtual Gateway" to assess people for entry into the system.
- 2) The entire county is behind the "systems" approach to coordinated care for clients (i.e., one assessment, one plan for any given client).
- 3) The next meeting will be on 7/20/12 at Salvation Army to evaluate goals, objectives, and services.
- 4) Once an assessment process is set up the HMIS will "house" data for people. The group is putting forms together for this process and they will meet on 7/19 at 3:00 pm at Salvation Army.

1) For future 4th of July street fairs we would like to have buttons with information or a slogan on them.
