Meeting was called to order by Chair Judy Alexandre

- 1. All present introduced themselves, and made announcements
 - 1.1. Announcements included: Downtown partners has reconnected a total of 219 people with family members,; David Deutch is new Exec. Director of NAMI; NAMI walk will be April 30; Community Action has hired Ron Irwin; 47,000 meals were served at Family to Family last year; Home Share event at Temple Beth Torah is October 29 at noon and includes a free lunch RSVP to Temple Beth
- 2. MSC to approve the agenda as presented.
- 3. MSC to approve the minutes as presented.
- 4. Treasurer's Report We'll be getting a check from VIMA to underwrite October 8 event; Dave will report on balance in October
- 5. New Business
 - 5.1. Laura's Law Mary Haffner reported that Laura's law changes the conditions under which caregivers may intervene if someone is ill and a dangr to themselves or others; it may fill a gap before jail or hospital release and stop revolving door, increasing the likelihood people will get needed treatment. Behavior Health Board has approved and it is now going through the Board of Supervisors. VSSTF already wrote in support. David Deutch added that NAMI supports Laura's Law
 - 5.2. Winter Shelter -
 - 5.2.1. VSSTF approved resolution asking for an emergency meeting of the Council's Subcommittee on Homelessness, but no emergency meeting took place. The items was part of a Subcommittee meeting held in September at Foster Library. Many people spoke. Judy felt we were clear in what we asked for, but some members of the Subcommittee asked for a letter again stating our specific requests. A letter was delivered to the members of the Subcommittee (see Appendix A)
 - 5.2.2. Peter reported that the city mangers of Oxnard and Ventura would be meeting October 8 to nail down funding and which armory would be used. Board of Supervisors approved use of some funding on a one-time basis. Cost should be about \$80,000 per month. Shelter manager, fiscal agent, and staff have all been identified. Cities will be guarantors of funding no matter what happens. Laundry has not yet been covered.
 - 5.2.3. St. Vincent and Red Cross will provide three hours' of training.
 - 5.2.4. No provisions have been made in the event heavy rains begin before December 1 shelter opening.

- 5.2.5. If a faith community or social service agency opens to fill gaps, they open at their own risk.
- 5.2.6. The feeling is that the plan this year has been made in "emergency mode." Cities need to commit in official vote that this won't happen again. There needs to be a vote on council's support for #7 in Recalibrated Plan that was adopted by Ventura City Council.
- 5.2.7. Project Understanding had been looking for a warehouse as a possible shelter site, but that is off the table now.
- 5.2.8. East County provides shelter with houses of faith providing shelter one night each week; such a model would be less likely to draw repercussions
- 5.2.9. There was much discussion regarding whether an armory could be used beyond the 6 am to 6 pm December 1 to March 30 open hours. See emails between Peter Brown and Ventura Armory director as Appendix B for answers to questions raised by members.
- 5.2.10.MSC (2 abstentions: Neal and Peter) to write or call our state senators regarding allowing use of armory free of charge and during expanded hours and days because of El Nino emergency conditions.
- 5.2.11.MSC (2 abstentions: Neal and Peter) to explore other areas of possible funding and reduced costs for use of armory
- 5.2.12.MSC (2 abstentions: Neal and Peter) to explore the possibility of expanding hours up to an including 24-hours

6. Reports:

- 6.1. Homeless Prevention Homeless Prevention Fund has served 965 people to date .
- 6.2. Faith Subcommittee The Committee finalized plans for the October 8 Partners for Change event at the Poinsettia Pavillion. All are invited
- 6.3. Housing People Can Afford met with Habitate for Humanite, Steve Dyer
- 6.4. Bridge Housing looked more at winter shelter, which detracted from ability of committee to focus on goal of creating ongoing bridge housing
- 6.5. Downtown Ventura Organization the DVO is supportive of a shelter with day services. We need to show City Council that we are all in this together and all people want a year-round shelter and day services. However, downtown businesses feel there is a concentration of services downtown.

Appendix A

To: The Homeless Subcommittee- Chairman Andrews, Mayor Heitmann, and Councilmember Weir;

We would like to clarify in writing our specific request and some of our comments made at the September 24th Homeless Subcommittee meeting.

We have come to believe that the City Council has directed staff to block or to significantly frustrate efforts to secure small year round shelters that bridge the gap while permanent housing is located or developed. These efforts have happened without the Council publically stating a position or voting on providing this necessary facility (ies).

Some of the indications of the roadblocks have been:

- Staff coming to the Sept 24 meeting with a last-minute winter shelter-only proposal (details still needed) after a two year notice that St. Vincent de Paul would no longer do so. They found that this model, as has been shown nationally, was expensive and did not assist people in moving out of homelessness.
- 2. A winter warming shelter subcommittee met for 2 years and was repeatedly told by staff that the Council would not consider even temporary zone changes or fee waiver. We are not aware of any formal vote on direction from the City Council.
- 3. Some of your subcommittee were not even aware of the winter warming shelter subcommittee's work with your staff.
- 4. The request by at least 21 members of the local clergy to meet with City Council was stonewalled for three months. Just trying to schedule a small meeting to discuss the larger meeting could not take place during that time.
- 5. Shelter proposals (including the Gateway concept) are blocked without a vote from Council occurring.

Since there is a lack of clarity of exactly where the Council stands on the issue of bridge (small shelters with services) housing, people and organizations have spent considerable time, energy and resources to no avail. These individuals, groups and organizations have been working in good faith to address the problem of homelessness in our city. We all want people off the street.

The Ventura Social Service Task Force and the faith community came in unity to the meeting on Sept.24, 2015. We want a public vote.

We are asking that the following be placed on the agenda of the next subcommittee:

That the City Council of San Buenaventura hold an up/down vote on the establishment of year-round bridge/interim housing (short term shelter) with services. The goal is to move people into permanent housing. This vote includes that the City will put forth its guidelines and extends an invitation to potential developers and service providers to submit appropriate plans.

We do not want any further meetings or discussions until after a public vote has taken place. Any conversation that is needed must be about moving forward. This cannot happen until the Council takes a position.

Ask as many questions, as many times as needed.

The responses are provided below:

* We know that, at this time, we would like to use the Ventura Armory from December 1 through March 31 - please confirm availability...

A: Yes, it will be made available.

- * my question is, would the Armory be available beginning on November 15 if the community can find the additional funding?

 A: Yes, the armory can be made available any time after Oct 15th with sufficient notice of intent.
- * Another question is related to the cost per night. You've quoted \$440 per night. There are some folks in our community who think they are aware that the rate in Los Angeles County is lower than \$440 per night. So I'm wondering if there's any wiggle room in the cost per night, and I'm also wondering whether or not it's accurate that there are different costs per night for

different armories.

A: Your source of information is in error. The price is standard and the same at all, except one, armory, which has a flat rate due to the condition and occupation status of the armory.

* The practice here in Ventura and Oxnard has been that the \$440 per night means 6 PM in and 6 AM out. My question is related to whether or not there's any flexibility in staying longer into the morning...perhaps 10 AM...and what the cost of that would be.

A: Unfortunately, the times have some, but not a substantial amount of flexibility, a matter of perhaps 1/2 - 1 hour. If the armory has an active unit occupying it, then the armory needs to be returned to operational status before duty hours in order to carryout military operations, which is priority.

* I'm also wondering whether there's any precedent to utilize the Armory 24 hours a day (either all of the time, or on some select days) during the period of time in which we will be open.

A: Unfortunately, if the armory has an active unit occupying it, then the armory will never be available for 24-hour operations for the Sheltering Program. However, for some weekends and holidays that may be an option, again depending on the schedule of operations and needs of the occupying unit. Yes, there would be additional costs, double.

* In the meantime, could you please send me the paperwork that will need to get moving on in order to secure the use of the armory?

A: Yes, the licenses will be distributed nlt Oct 15th.
