- I. Call to order
- II. Introductions (included reactions or thoughts regarding the council meeting of 3/20/17)
 - a. People expressed general disappointment with the City Council delaying the final passage of the zoning change until 4/10.
 - b. However, people did appreciate the excellent attendance of the meeting in support of the ordinance.
 - c. Judy Alexandre commented that a post-council meeting discussion gave her hope for future progress.
- III. Approval of or changes to the agenda for 4/5/17 as emailed (MSC).
 - a. Judy Alexandre noted that you must have attended 3 of the last 5 VSSTF monthly meetings to be eligible to vote on motions.
- IV. Approval of or changes to the minutes of 3/1/17 as emailed (MSC).
- V. Treasurer's report (Dave Schmutte)
 - a. No change to balance (\$3,837.51).
- VI. **New Business:**
 - a) Presentation of Laura's Law Implementation (Rebecca McCloud, Nicole Horne, Antonio Rodriguez) - Assist Program.
 - a. Dr. Schipper is director of Assist Program
 - b. Have received 4 year SAMHSA (Substance Abuse and Mental Health Services Administration) grant for \$1M/year, plus an additional \$600K from the Ventura County Board of Supervisors.
 - c. Assist Program officially launched on 1/30/17, although it was in development for several years.
 - d. Intended to help people who keep going in and out of hospital
 - e. ACT (Assertive Community Treatment) based
 - f. In California, must allow people to voluntarily participate in program
 - i. Other states start immediately with court orders.
 - ii. Don't offer sanctions for failing to comply
 - iii. Can't force medications
 - iv. Can't require placement in locked facilities
 - v. Can't use physical restraints
 - g. Antonio Rodriguez presented referral sources (provided on handout)
 - i. Mostly family, roommates, or directors of agencies providing treatment

- h. Tara Carruth asked how homeless people get referrals, since many have no close relatives.
 - i. Judy Alexandre noted that this could be a mentally ill homeless person not at Hillmont, in jail or with family
 - ii. Rebecca McCloud - If called by a non-qualifying person (for referral), the person is automatically eligible for RISE (Rapid Integrated Support & Engagement).
 - iii. Nicole Horne - When RISE engages, a case history is started, which will help get Assist involved if necessary/possible.
 - i. Criteria for Assist AOT (Assisted Outpatient Treatment) Program (9 criteria must be met, list provided on handout)
 - i. Nicole Horne - Will check court documents for evidence of violent behavior.
 - ii. Jan Schmutte asked if all 9 criteria must be met.
 - 1. Rebecca McCloud - Yes, but still call. It will get RISE involved, which can possibly lead to Assist.
 - j. Neal Andrews - Concerned with reliance on referrals.
 - i. We should be going out to look for people who need help.
 - ii. Judy Alexandre - There are people too ill to recognize that they are ill.
 - 1. Outreach workers try to develop relationships with people in need of assistance.
 - 2. Outreach workers need stronger relationship with RISE personnel.
 - k. Karol Schulkin - What happens when there is a referral for someone who is homeless and meets the criteria?
 - i. Rebecca McCloud - It is possible for Ventura County Behavioral Health (VCBH) to provide short-term loans to help get housing
 - 1. Especially for people just coming out of prison.
 - 2. VCBH will help people fill out forms, look at places, etc.
 - ii. Note: Sober living facilities do not support the use of medications.
 - l. Update: As of 4/5/17
 - i. 42 Assist Calls
 - 1. 4 were information only
 - 2. 38 referrals
 - 3. 60% - family/friends
 - 4. 30% - mental health professionals
 - 5. 10% - other
 - ii. 11 through screening process with RISE & referred to Assist.
 - iii. 1 person is ready to proceed with Assist; several people are eligible and in the process.
 - m. Judy Alexandre requested electronic copies of VCBH presentation materials.
- b) Presentation by Ventura Bike Hub (Yvonne Adan, Michael Tweet)

- a. Michael Tweet - homeless for 12 years
 - i. Found support in community by learning how to work on bicycles.
 - ii. Wants to teach homeless people to be certified bicycle mechanics.
 - iii. Looking for ways to get referrals to program or walk-ins.
 - iv. WA man developed a design for a bicycle camper that is a very good temporary sleeping shelter.
 - v. Wants to do street outreach (e.g. to river bottoms).
- b. Judy Alexandre - On Mondays, people can go to Ventura Bike Hub (VBH) to earn bikes.
 - i. Earn bikes through work-trade credited at \$10/hour
 - ii. VBH can provide 3 levels of bike mechanic certification plus other skills (e.g. cashier)
- c. Michael Tweet - People can earn used bikes.
 - i. Haven't looked at how to provide parts yet.
- d. Yvonne Adan - VBH needs funding to pay for wages.
 - i. Karol Schulkin asked what is projected annual budget.
 - 1. Yvonne Adan noted \$56K.
- e. Miguel Marquez - what about liability for workplace injuries?
 - i. Someone answered - If someone gets referred to VBH & are injured, the referral agency is not held responsible.
 - ii. Pam Marshall noted that having people sign a waiver would be advisable.
- f. Ventura Bike Hub - (805) 641-2665
 - i. Tu, Th, Fr - 3-7pm; Sat - 11am-3pm.
 - ii. 1115 N. Ventura Ave, Ventura.
 - iii. action@vccool.org and toby@vccool.org
- g. Manuel Minjares - Met with VBH to discuss expansion into neighboring communities.
 - i. Feels that it could be helpful to River Haven.
- h. Judy Alexandre - Encourages agency reps to meet with VBH to develop a relationship and provide referrals.
- c) Recuperative Care update Sandra Troxell, Salvation Army (5 min)
 - a. Not covered, will be discussed at next month's meeting. The National Hospital Association will be making a presentation.

VII. Old Business:

- a) Update from city council meeting of 3/20/17 and plan for meeting on 4/10/17 (Judy Alexandre, Karol Schulkin, Jerry Breiner)
 - a. Jerry Breiner - The Shelter/Housing Subcommittee of VSSTF had a meeting with a potential partner for planning a shelter with services.
 - i. Very preliminary, but encouraging.
 - b. Peter Brown - Want people to take care to look only at the actual motions from the council meetings, as they are the only official statement/actions.
 - c. Judy Alexandre has asked 4 conservative clergy to write a letter to the VC Star

and the Citizens Journal in support of the Emergency Shelter Ordinance (as a response to recent letters published in opposition to the ordinance).

- d. Judy Alexandre indicated a need for some presence at the 4/10 council meeting.
 - i. Presence is intended to be thanking the council for the progress that they are making.
- e. Peter Brown - Staff is planning to ask for approval of the changes only.
 - i. Do not want to go through the entire presentation again.
- f. Neal Andrews - Got memo from Todd Collert with concerns about proposed changes to the ordinance.
 - i. Changes may make it too hard to move forward.
 - ii. May need to go back and address issues/flaws after the ordinance is approved.

b) Final report from the winter warming shelter (Peter Brown)

- a. Total End Users (with at least 1 stay) = 700+
- b. Total Stays = 10,699 (Dec = 2,227; Jan = 2,988, Feb = 2,915, March = 2,769)
- c. Total Meals Served = 21,000+
- d. Karol Schulkin requested a detailed breakdown of Ventura/Oxnard clients
 - i. Peter Brown - For every 5 clients, ~3 are from Oxnard, ~1 from Ventura & ~1 from elsewhere, but there will be a more detail provided later.
