 - a. Covered: Who can petition, must be 18, psychotic or schizophrenic. Homelessness alone is not an indicator; Difference between voluntary care agreement and involuntary care plan. Both have 4 components: Mental health care, education housing and case management. Info is on https://www.ventura.courts.ca.gov/care.html and https://www.ventura.org/care-act/ Petitions MUST be in person Vta Hall of Justice or Juvenile Site.

 - ii. One Stop mentally ill clients. What to do? Maybe connect with RISE to start. One stop employees can initiate
 - iii. Program success 12/2/2024 started 6 clients; current capacity for clients unknown
 - iv. Process STARTS with the Courts
- VI. Goal setting and VSSTF priorities discussion and decision (Judy Alexandre) Previous goals:
 - Foul Weather Shelter expansion (Judy) now 40 beds; Rain (1/2/") & temp (<45) some LA fire displaced families are using hotel rooms. River Community does a great job with the first 20 beds; next 20 rooms is TBD
 - Laundry of Love (John Jones) \$500/month; 2 sites now; 2-2.5 hours, free laundry washes & dry. Don't have to prove homelessness. Miguel will look for a new site.

- Looking for a midweek weekday across town. Oxnard has four days seems to be limited to Farm Workers
- RV dumping station (Kappy Paulson) probably no go for station; but maybe 1-2 pump truck; Consider going legislative route Via county Envi Services Jen mentioned VC county is doing more of an enforcement approach and not a service. CoC and grants don't allow THAT use of \$. Can we get Talk with Assembly person to get info Mike no relationship with Monique or Steve. Brian Brennan & Surfriders, Mike will contact. PIT 2024 21 RV in Ventura w no hookups and PIT 22025 25 RVs Many commented RV count is probably a LOW number. Council needs Data i.e Numbers of how many RVs are here
- Plan for RV parking day and eve with case management- Like an RV park that caters to talking with Community Development. Maybe similar to River Haven
- Storage (John Jones and Leona Rollins) Leona checking Harrison donating bins. Need Data about who would use service, John wants 250 barrels. Where can we store? & Capacity of the storage area. Hours? Manage access?
 - had reached out to her regarding who may be ideal person at EJ Harrison to connect with. E.J. Harrison & Sons began replacing trash, recycling, and yard waste containers in Ventura, California in early 2021 to comply with Senate Bill 1383:

Trash: Black carts replaced green ones; Yard and food waste: Green carts replaced tan ones; Recycling: Blue carts remained blue

The new carts are slightly shorter but wider and heavier than the previous ones, making them more stable in windy conditions. Customers were notified when it was their turn to receive the new carts, which came with instructions on how to use them. The state requires all carts to be replaced by 2036, but E.J. Harrison expects to complete the transition within a few years.

- Need for bus passes (Judy Alexandre) Need a grant for Bus passes. Gold Coat transit has a short fare button, driver can waive fee. Consider a grant from AAA Miguel. VC Transport Commission probably won't help.

 - Add work with H4All re Housing Advocacy. H4A is lead for housing support & partner w H4 All in the area of affordable housing. See Sheetz decision See below
 - Legal challenges to Sheetz decision. https://bbklaw.com/resources/la-041624-scotus-moves-on-sheetz-development-impact-fees-imposed-by-legislation
 - Sheetz v El Dorado case puts a much higher legal threshold for development fees. California is particularly affected because our state threshold was much lower. Moreover, Sheetz means plaintiffs can challenge state/local fees in federal court as unconstitutional.
 - Inclusionary zoning fees were challenged in Oakland and Healdsburg,
 but before it went to court the cities settled or backed down

 City doesn't have that anymore. Woods Services, via Measure O, might do it.

 - Several New Tenant Protections Went into Effect for Renters in California this
 Month | National Low Income Housing Coalition
 - AB2801 Security Deposit protections LL can only up to move out date & not any damages after move out. LLs 4/1/2025 must take photos after m/o & B4 repairs are dne 7/1/2025 share w tenants and receipts
 - SB 611 Allowable Rental fees & limit fees charged & strengthen security Deposit Laws. IF more than 1 month, LL must report reason
 - AB 2747 Positive Credit Hx for rent reporting at start & once a year existing tenants also included.

- AB2493 Screening fee \$30/applicant w adjustments for CPI,
 Only IF intend to rent unit. Tenant can access screening report in 7 days
- AB 2347 Unlawful Retainer allows 10 days to respond vs 5 days.
- SB1051 DV Survivors 24 hr lock change, Tennent must provide confirmation documentation. LL covers cost of lock.
